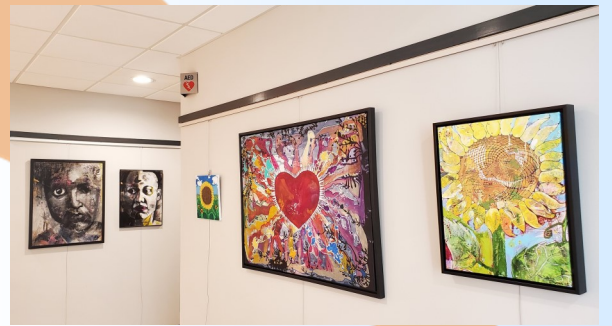
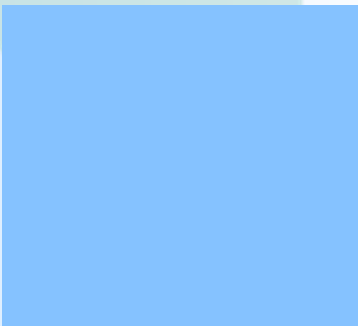
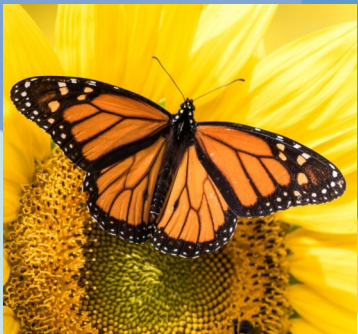

TOWN COUNCIL

The Town of Knightdale has a Council-Manager form of government. Under this system the citizens elect a mayor and five council members as the Town's governing body. The Council then appoints the Town Manager who serves at the discretion of the Council. Council members are elected to four-year terms. The Mayor, as the principal elected official of the town, provides leadership to the governing body and the community, and presides over council meetings.

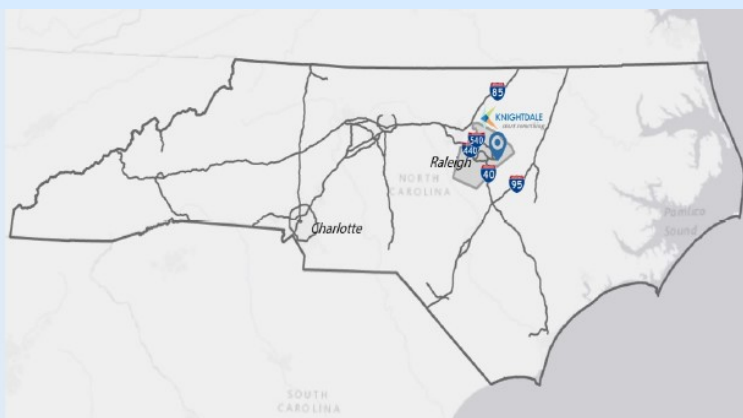

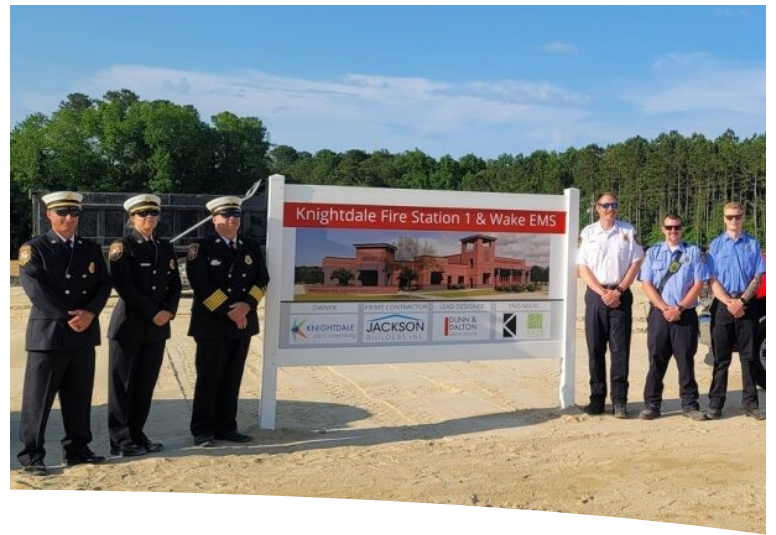

ABOUT **KNIGHTDALE**

Incorporated in 1927, the Town of Knightdale is located in Wake County, just seven miles east of Raleigh, the State Capital of North Carolina. It has a corporate limit comprised of 7.81 square miles and an extraterritorial jurisdiction of 17.38 square miles. With a population of only 243 in the 1930 Census, the Town’s major growth started in the 1990s, and today, it is recognized as one of the fastest growing municipalities in Wake County, the State’s second largest county.

Knightdale is a dynamic community full of opportunity, welcoming those who want something different. It is a place citizens can call their own, where the culture is decided by the people, and a place that encourages its citizens to make the Town what they want and gives them the freedom to be themselves.

The Town’s tag line, “Start Something,” is more than a motto. It is a mindset, not only for citizens, businesses, and community partners, but for the Town itself. A major accomplishment in fiscal year 2023 was the creation of a Community Relations Department. This department will oversee the Town’s overall community engagement, economic development, and communications. Work is currently underway on some major Town initiatives. In the previous fiscal year, Town Council placed an emphasis on meeting public safety needs by directing staff to pursue two new fire stations and a law enforcement center. Construction has begun on both fire stations. The Hodge Road Fire Station is scheduled for completion in fiscal year 2024. The Forestville Road Fire Station is scheduled for completion in early fiscal year 2025. The design contract was awarded for the law enforcement center remodel, with construction scheduled to begin in early fiscal year 2025. These are only a few exciting changes started and coming as Knightdale continues as a place to live, work and play.





GROWING **ECONOMY**

The Town of Knightdale’s diverse economy is supported by businesses of all shapes and sizes from locally-owned shops to nationally recognized corporations. Its economy benefits from the proximity to the City of Raleigh and the Research Triangle Park, which includes Raleigh, Durham, Chapel Hill and surrounding communities. This area is considered one of the best places to live and work in the United States. Unemployment has decreased to 3.4% compared to 3.6% at the same point last year. The median household income is \$72,118.

Town of Knightdale Adopts Comprehensive Transportation Plan



Adopted in fiscal year 2023, the Town’s Comprehensive Transportation Plan (CTP) presents a long-term vision for roadways, transit and bicycle and pedestrian facilities in Knightdale. The plan was developed over a year long process which included extensive public and stakeholder outreach. The CTP will guide the Town in pursuing projects to implement the long-term transportation vision. Current priorities are improving safety and connectivity, boosting transit ridership and expansion of the bicycle and pedestrian network. In the future, priorities will likely shift to system maintenance and alternative modes of transportation as many widening projects are completed. This Plan will also assist in securing funding for transportation projects from federal, state and local transportation partners.

ECONOMIC SUMMARY

In fiscal year 2023, the Town’s tax base has continued to grow. The number of building permits issued increased by 20% in the last calendar year, bringing a total of 115 million in assessed property value into the Town. Of the 115 million, 58% is related to commercial development. This positive trend has brought new jobs to the area. Knightdale is a wonderful place to live, raise a family, work, and establish a business. In addition to providing a highly desirable quality of life for every type of business and its workforce, Knightdale is an excellent marketplace for businesses and entrepreneurs to offer goods and services of all descriptions.

EDUCATION RESOURCES

The Town is served by Wake County Public School System (WCPSS), the State’s largest school system and 15th largest in the country. Knightdale is home to six WCPSS schools: four elementary schools and one each middle and high school.

Institutions of higher education within 20 miles include: Wake Tech, NC State, Shaw, William Peace, Saint Augustine’s, and Meredith.

GENERAL FUND

The General Fund is the Town's primary operating fund. It accounts for all financial resources of the general government, except for those required to be accounted for in a different fund. These other, smaller funds are used for specific purposes with more Information being found in the Annual Comprehensive Financial Report (ACFR) on the Town's website.



FUND BALANCE QUICK FACTS FOR FY2023

Fund Balance is the difference between assets and liabilities in a governmental fund. Generally Accepted Accounting Principles (GAAP) provide the hierarchy of constraints placed on how fund balance can be spent. Information on fund balance classifications can be found in the notes of the ACFR.

- At the end of the fiscal year, the total fund balance for the General Fund was **\$13,579,538**. The unassigned fund balance was **\$9,453,325**.
- Town Council policy says the Town should maintain an unassigned fund balance of 25%—four months of general fund expenditures—in cases of unforeseen needs or opportunities in addition to meeting cash flow needs of the Town. The Town has exceeded this with an unassigned fund balance of 35.6%.
- Any unassigned fund balance over 40% gets transferred to the Town's Capital Reserve Fund to offset costs of future capital projects. No funds were moved in FY2023.

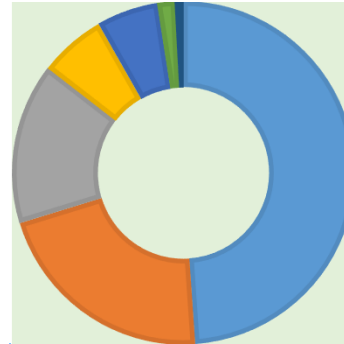
Property taxes are the single largest source of revenue for the Town of Knightdale consistent with all other municipalities and counties in North Carolina. The Town also shares in a portion of sales taxes collected and remitted to the NC Department of Revenue by retailers and others. While the State retains the majority of collected sales taxes, portions are allocated back to local governments according to state statutes. To mitigate the overall impact on citizens, where possible the Town charges specific end users for the costs of services. These amounts are reflected in the Sales & Services and Permits & Fees categories. Recreational programming, trash pickup, and building permit fees are examples of these types of revenues.

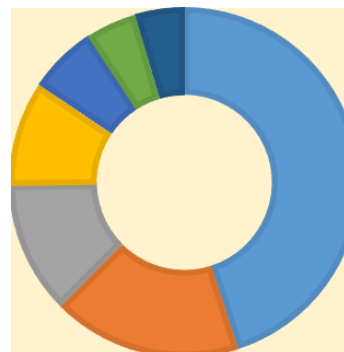

While expenditures can be broken out by function as seen on the right, amounts can also be viewed by type. Of the total General Fund amount expended in fiscal year 2023, **\$13,046,436** or 50% of the total was spent on personnel services. This includes salary and benefits for full-time employees and limited service staff. Operating costs totaling **\$6,921,271** or 27% was the next largest amount. These costs include utilities, fuel, general maintenance, and any other expense necessary for providing routine services to residents. The Town spent **\$4,127,509** or 16% of total on capital items, which includes vehicles and large equipment. Debt service accounts for 7% or **\$1,781,040** of the remaining amount.

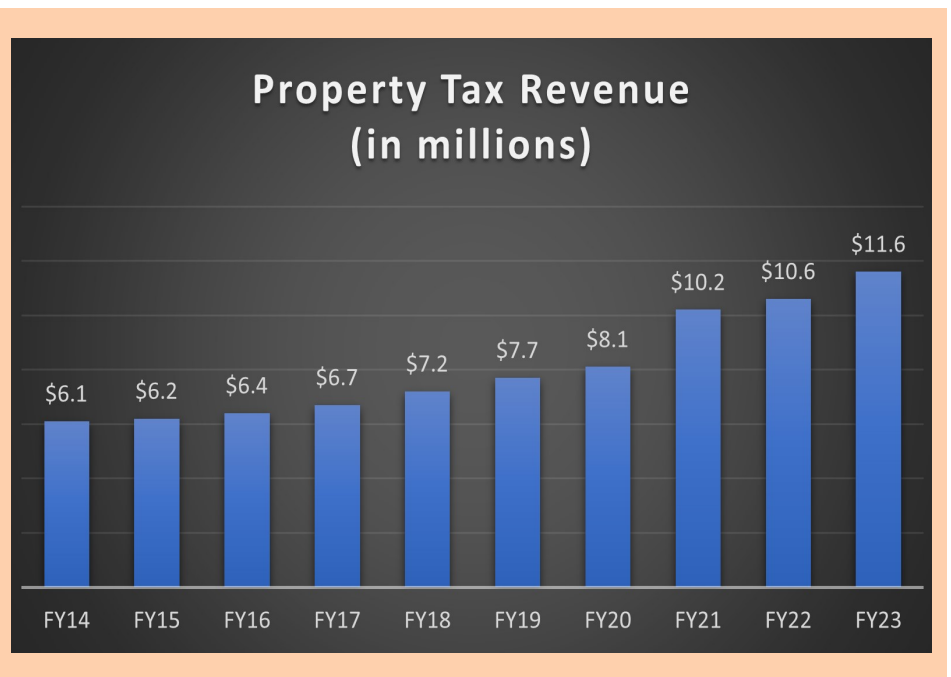

PROPERTY TAXES

For the Town to provide the many types of services for citizens, it needs to generate revenue. The main source of revenue is Ad Valorem (property) tax. Property taxes make up **46%** of the General Fund revenues of the Town and are assessed and collected for things such as real estate, business and personal property, and motor vehicles. To equitably tax citizens, the Town relies on the Wake County Tax Department to review ownership and condition of taxable property as of January 1st of each year. A tax rate is set per \$100 assessed value. The total assessed value of property for Knightdale in 2023 was **\$2,570,361,556**. The Town's **property tax collection rate** was **99.76%** for 2023.

GOVERNMENT-WIDE STATEMENTS

The government-wide financial statements look at the Town of Knightdale as a single, integrated unit and use the full-accrual basis of accounting. These statements are designed to provide readers with a broad overview of the Town's finances in a manner similar to a private sector business (balance sheet and income statement). They provide short and long-term information about the Town's financial status as a whole and can be found on Exhibits 1 and 2 of the ACFR. Information presented includes only governmental activities.

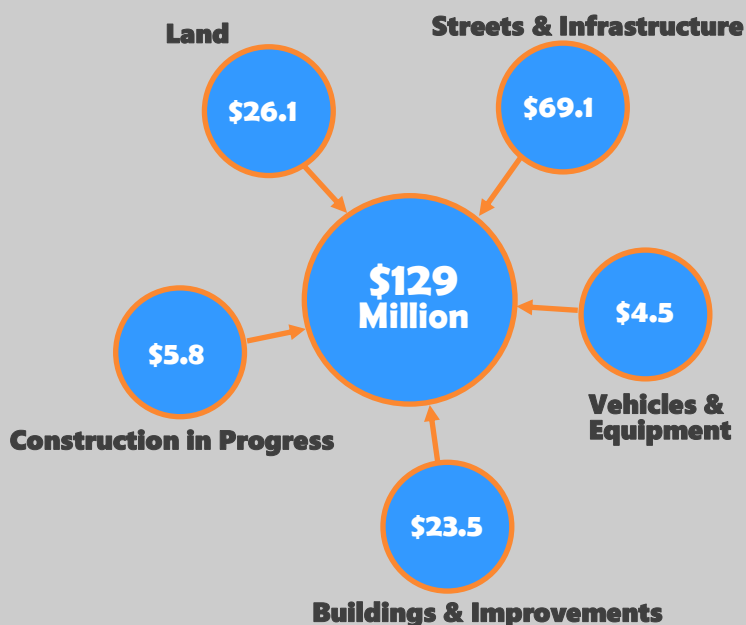

Income Statement

This report provides a summary of amounts received (revenues) and amounts spent (expenses). The difference between revenues and expenses shows in the Town's net position. A positive change indicates the Town had enough revenues to cover its obligations and has the ability to save for the future.

CAPITAL ASSETS—NET OF DEPRECIATION (in millions)



Over time increases and decreases in net position may serve as a useful indicator of whether the financial position is improving or weakening. For the fiscal year ended June 30, 2023, the net position increased **\$17,199,930**. The increase in net assets was due in large part to developers donated streets and sidewalks.

Over 90% of the Town's net position is capital infrastructure representing land, streets, buildings, vehicles and other major equipment that the Town uses to provide services to its citizen.





OUTSTANDING DEBT

The Town of Knightdale sometimes issues debt to fund its general governmental and business-type capital needs. The total outstanding debt as of June 30, 2023 totals **\$20,303,865**. This is an **increase of \$10,096,563** or 98.92% from the prior year. The Town has a policy which provides guidance and direction when considering the impact of debt and actively monitors and manages its debt capacity and affordability. The Town is operating within the parameters of this policy. The total amount spent—principal and interest—on debt service in FY2023 was **\$1,781,040**. This is a **decrease of \$71,600** or 3.86% from the prior year.

General Obligation Bonds are backed by the full faith, credit and taxing power of Knightdale. The collateral for installment purchase agreements are the assets purchased or constructed. Leases are defined as a contract that conveys control of the right to use another entity's nonfinancial asset (the underlying asset) as specified in the contract for a period of time in an exchange or exchange-like transaction. Subscription Based Information Technology Agreements provide governments with access to vendors' IT software and associated tangible capital assets for subscription payments without granting governments perpetual license or title to the IT software and associated tangible capital assets.



GENERAL GOVERNMENT

General Government is the administrative function of the Town of Knightdale. These departments provide the necessary financial and human capital infrastructure to ensure Town services are carried out. Primary is the Administration Department led by the Town Manager, who is responsible for all municipal functions and ensures the Town operates in compliance with federal, state, and local regulations. General Government expenditures represented 20% of the General Fund budget in FY2023 or **\$5,138,579**, of which **\$2,097,035** was for personnel costs, **\$1,631,408** spent on capital, and the balance of **\$1,410,136** used for operations and maintenance costs.

STRATEGIC PLANNING

Updated in 2023, the Town’s **Strategic Plan** incorporates robust input from all of its stakeholders and was developed as a proactive strategy to augment its citizens’ future quality of life. The plan’s purpose is to communicate clearly the message of **“who we are and what we want our Town to be in the future.”** It is built around five essential priority areas that are vital to ensuring Knightdale's future. Safe, Active & Healthy, Connected & Inclusive, Sustainable, and Organizational Excellence serve as the foundations for service delivery decisions, capital investments, and other initiatives for the Town.

PUBLIC SAFETY FIRE

The Knightdale Fire Department is responsible for protecting the lives, property, and the environment of the citizens and visitors to the Town of Knightdale. The department responds to calls of service out of three stations with 50 full-time positions. For the fiscal year 2023, the Fire Department spent **\$5,981,526** of which **\$4,913,972** was for personnel services, **\$151,417** spent on capital and **\$916,137** for operations and maintenance. Fire services extend outside of Town limits; and therefore, the Town participates in the County’s Fire Cost-Share program. In fiscal year 2023, the Town **received funding of \$2,411,761** from the County.

Town Breaks Ground on New Fire Station

The Town of Knightdale initiated the construction of the Forestville Road Fire Station during fiscal year 2023 with an estimated completion date of early fiscal year 2025. The Forestville Road Fire Station will boast state-of-the-art infrastructure, incorporating advanced firefighting equipment and cutting-edge technology to enhance response capabilities.





PUBLIC SAFETY POLICE

The Police Department seeks to serve by ensuring the safety and security of all who live, work and visit the Town of Knightdale. It does this through its professional policing and community partnerships and an adherence to its Core Values known as PRIDE: Professionalism, Respect, Integrity, Dedication and Ethical Conduct. The KPD is comprised of three separate divisions made up of 42 sworn and non-sworn personnel. In fiscal year 2023, the Town spent **\$4,806,989** for police services, of which **\$3,607,166** was for personnel services, **\$309,242** was for capital, and **\$890,581** was for operations and maintenance.

KPD Citizens Police Academy Returns

In fiscal year 2023, the Town’s Citizens Police Academy (CPA) returned. The CPA is an excellent way for community members to become better informed about crime and public safety. It also gives Knightdale residents and other community stakeholders an opportunity to develop working relationships with Police Department members.

DEVELOPMENT SERVICES

The Development Services Department facilitates sustainable growth through regulations that promote a balance of the built and natural environments. It is the central point of contact for the Town for all development-related needs and oversees the entire development process from permit application submittals through the issuance of certificates of occupancy (CO). This department ensures that all development activities are conducted in accordance with the Knightdale Unified Development Ordinance (UDO) and North Carolina Building Code. Annual expenditures were **\$1,448,120** of which **\$733,837** was for personnel, **\$439,614** was for capital, and **\$274,669** was for operations and maintenance.

Town Adopts River District Small Area Plan

The River District Small Area Plan creates a clear vision for the district and provides guidelines and policy statements for future private development related to permitted land uses, architecture, infrastructure, and cohesive signage and branding. The plan also helps the Town identify opportunities for future public projects, such as improving walkability and connectivity by filling in greenway and sidewalk gaps. Possible re-development opportunities and park/open space needs are also explored. The plan also:



- Created four new guiding principles to be used in addition to those in the KnightdaleNext 2035 Comprehensive Plan
- Emphasizes creating a walkable, connected community that provides ample destinations and recreational activities
- Revised the Town's Growth & Conservation Map to expand several mixed use centers, introduce a neighborhood node, and create a new Trail-Oriented Development place type

PUBLICWORKS

The Public Works Department maintains existing public infrastructure, plans and constructs capital improvements, and protects public health and safety and natural resources. In fiscal year 2023, it had **\$3,652,982** in annual operating costs. Of this amount, **\$1,571,639** was spent on general operations, **\$854,586** was used for the upkeep of grounds and buildings, and **\$1,226,757** was spent on streets and sidewalks. Like all NC municipalities, the Town receives funds from the State primarily for street resurfacing, but it can also be used for construction and maintenance of roads, bridges, sidewalks, and greenways. The Town had **\$810,962** available at year end.

Knightdale Celebrates Creek Week 2023

Knightdale's Creek Week is a collaboration between the Town, NC Clean Water Education Partnership, and Wake County Public Libraries. A variety of events are hosted to celebrate and educate the community on the importance of clean and healthy waterways. During Creek Week 2023, Knightdale hosted a Story Walk, Arbor Day Tree Planting, Volunteer Litter Sweep, Tree Giveaway, and Shred-A-Thon.





PARKS RECREATION & CULTURE

The mission of the Town’s Parks, Recreation and Cultural Programs Department is to enhance the quality of life for citizens of all ages by providing an experienced staff to plan, implement, and manage a wide variety of passive, active and cultural opportunities. Department expenditures for fiscal year 2023 were **\$1,764,851**, with **\$717,680** spent on personnel costs, **\$629,192** used for operations and **\$417,979** spent on capital related items. Programming costs were offset by **\$239,700** in recreation and service fees.
